### **Registration**

Every citizen (a) who is at least seventeen (17) years of age and will be eighteen (18) years of age on or before the next Town election and (b) has resided within the corporate limits of the Town for thirty (30) days, is eligible to register to vote in Town elections. Town residents who wish to register to vote may do so with the Cecil County Board of Supervisors of Elections by calling 410-996-5311 or by visiting the Town Hall.

If you are not sure if your street is in corporate limits, click street listing to check for your street and address.

### Nomination of Mayor and Commissioners

Qualified voters may seek election or re-election of the office of Mayor or Commissioner of the Town of North East by filing a certificate of nomination at the Town Hall, on or before the second Monday in January next preceding the Town election. In addition, a "Financial Disclosure Statement" form, an "Appointment and Acceptance of Treasurer and Campaign Manager" form and "Limiting Campaign Contributions and Expenditures" form. For forms and deadlines to file forms click nomination package.

No person shall file for nomination to more than one elective Town public office or hold more than one elective Town public office at any one time.
