- Article 3. Definitions. Parking space size for off-street parking.
- Article 6-8. To amend the parking space size to 9' x 18'
- Section 6-29: Assisted Living facilities/group homes: To delete the requirement for a residential group home to provide evidence of a state and federal license to delete conditions for a residential group home.
- Adding a provision that large institutional group homes shall be subject to conditions of Section 6-29.
- Deleting the requirement for residential group homes to be subject to a 1500 foot distance requirement from other group homes
- Adding a 1500 foot distance requirement for large group homes/assisted living facilities.
- Deleting the sign requirements for residential group homes.
- Providing for permitted signs for large institutional group homes in Article 7. Signs.
- Amending the table of contents, paragraph re-lettering and renumbering, page numbers and index pages to reflect changes to the text.

# **Ordinance 2014=03-01**:

Commissioner Braley made a recommendation for approval of Ordinance 2014-03-01 to the Mayor and Commissioners. Mr. Langille seconded the motion. The motion was approved by all.

## -MISCELLANEOUS-

### North East Commons:

Mrs. Cook-MacKenzie reported that during the February 2014 meeting, she discussed North East Commons. Specifically, the part owner of North East Commons contacted the Town to inquire whether the Town would consider the use of a 600,000 square foot cross dock warehouse on this land.

Mrs. Cook-MacKenzie reported that she was concerned about the zoning ordinance allowing warehouses, by right, in Highway Commercial District from the Zoning Ordinance, and stated that warehouses are a "permitted use in a completely enclosed building". The Planning Commission believed that the intent of the Highway Commercial District was sufficient to outline that a cross dock facility is an inappropriate use in the Highway Commercial District.

## Library:

Mr. Langille inquired about the status of the library project. Mrs. Cook-MacKenzie reported that the Library Committee continues to have dialogue with the property owner of the potential site.
