Mr. Natale is asking board approval for destruction of the listed records which are currently stored in 146 boxes and no longer have any operational or historical value.

## Board of Supervisors of Elections – Proposed Regulation Amendments

Mrs. Cook-MacKenzie reported the Board of Supervisors of Elections would like to finalize an extensive amendment to the Code of Ordinance and or Charter in regards to the Election Procedures and Regulations. Mrs. Cook-MacKenzie would like the Mayor and Commissioners' thoughts about an amendment that if there is an uncontested election that the election would be canceled and the individuals on the ballot would be automatically appointed.

After discussion it was determined such an amendment would not be supported by the Mayor and Commissioners.

## Maryland State Highway Administration - Lights over the Amtrak Bridge

Town Administrator Melissa B. Cook-MacKenzie presented a draft of Memorandum of Understanding as part of the Improvements, State Highway Administration has agreed to continue the pedestrian lighting across the bridge to match the existing lighting along Maryland 272. Mrs. Cook-MacKenzie requested a copy of plans from State Highway before any approval from the board. The MOU requires a 10% match from the Town.

#### -MISCELLANEOUS-

Phillip Meekins, Supervisor of the Maintenance Department reported he spoke with Michael Morgan about the Christmas tree at the North East Community Park after the last meeting when the board directed him to gather information about replacing the tree. According to Mr. Morgan the existing tree needs to be removed and replaced. A replacement tree could cost upwards of \$3,000. Mr. Meekins will provide the Board with different options and costs at the next meeting.

Mrs. Cook-MacKenzie reported this year Flag Day will be held on Wednesday, June 14, 2017, this would fall on a board meeting. Ms. Cook-McKenzie would like to confirm with the board to change the time to meet from 7:00 p.m. to 7:30 p.m. After discussion the board concurred and agreed to move the meeting time that day.
