Discussion on revisions to "Policies & Procedures: Vendors at the North East Community Park" Commissioner Kline requested the Board to relook at Resolution 2016-05-01, for the Food Vendor Trucks at the North East Community Park with a pre-established designated area. This amendment was originally approved by the Board on May 25, 2016. After review of the document, the Board agreed on modifying the Policy and Procedures to allow for two to three month permits per allowed use per year with a permit fee of \$150.00 per permit. The Director of Finance and Administration was directed to re-advertise.
