# Director of Planning and Zoning

Commissioner Benson inquired about the "wish list" items Mr. Gregg would like considered for the ARPA funds. Mr. Gregg commented on the following items:

- The Maintenance Department currently only has one zero turn mower. Therefore there is a need for additional mowing equipment which would cut down on mowing time significantly.
- A storage container is needed, due to loss of storage areas such as the red barn, to store decorations such as Christmas wreaths and special event items.
- The Old Town Lock-Up restoration would be an asset to the Town.
- A trash truck would be beneficial during special events and bulk trash pick-up.
- Additional electric outlets for the park would be helpful during special events.

## Water Plant Superintendent

Commissioner Benson inquired about the "wish list" item Mr. Carter would like considered for the ARPA funds. Mr. Carter commented on the following item:

Tank ladder: the tank is approximately 45 feet in height and was built without a ladder. Mr. Carter stated that in the past the Town has had to rent equipment to reach the top of the tank. Commissioner Benson inquired if there was another piece of equipment that would accomplish the same result and could be utilized for other uses within the Town, such as a scissor lift. Commissioner Mitchell suggested a bucket truck and Mr. Carter replied it would depend on the type and height it could reach. Commissioner Benson stated a bucket truck could also be used for hanging Christmas wreaths, changing light bulbs, flags and many other things.
