Resolution 2022-12-01 Cecil County Hazard Mitigation Plan – 2022 Hazard Mitigation Plan Update

## Director of Planning and Zoning

Mrs. Vennell entered into the record the November 21, 2022 Planning and Zoning Monthly report. In addition, Mrs. Vennell reported the following:

- FEMA meeting with Cecil/Harford Counties regarding compliances and the FEMA claims over the past 10 years. They are requesting the process and procedures from the municipalities to identify structures that are damaged 50 percent or greater
- Public Hearing in November, for a Pub Restaurant and this was continued in December for further discussion
- Ridgely Forest had a minor amendment, housing unit types, the size and reducing the driveway
- North East Station and the proposed Starbucks, Lot 4, final approval for the site plan
- Ridgely Forest had 10 new building permits for the month of November. For the
  month of December there are 8 permits on hold until the Planning Commission meets
  in the month of January. The total of occupancy is 430 with less than 100 for full
  capacity
- 25 permit invoices and 6 occupancies for new homes

Per the letter from the Ford Motor Company, due to the current market conditions and the supply chain the invoice has increased in price. The increase for the plow, \$3,142.36 with the truck increase of \$5,989.67 with a total of \$9132.03.
