A. SUMMARY OF PROJECT

The Mayor and Commissioners of the Town of North East, Cecil County, North East, Maryland are required to undertake updates and refinements of the North East Comprehensive Plan-2012 (current Plan)-2012 (current Plan), including associated illustrations and maps. The Mayor and Commissioners are requesting proposals from qualified Consultants with local government experience to prepare updates and refinements to the North East Comprehensive Plan-2012 (current Plan). The updates and/or refinements to the Plan shall comply with all provisions of the Maryland Land Use Article: Division I. Title 3.

Section 1-509: Updated Tier Map

Section 3-102. Elements (a) and (b);

Section 3-103. Development regulations element;

Section 3-104. Sensitive areas element,

B. TASKS

Note 1. The Town and WILMAPCO worked together to revise the Transportation Element, which is now approximately 75 percent complete. The completion of the Transportation Element shall be required by the consultant chosen for this project.

Note 2. The Town's Engineer was hired to update the data within the Water Resource Element and the Municipal Growth Element, which are approximately 75 percent complete. The Completion of these Elements shall be required by the consultant with this task.

- Critical review of the current North East Comprehensive Plan-2012 (current Plan), Maps and Illustrations and aggressively work with the Towns' visions for the future. Implementation of the requirements of the Maryland Land Use Article Section 3-102 through Section 3-114. Section 1-201 and Section 1-509, also identified in A. SUMMARY OF PROJECT.
- 2. Project Meetings: The Consultant is expected to engage and interact with the North East Planning Commission, Mayor and Commissioners, North East Economic Development Committee, County and State agencies, Town Engineers and Town staff to discuss project progress and direction.
- 3. Public Engagement and Communications: The Consultant shall be required to develop a public participation process designed to engage the residents in visioning the future of the Town. The Consultant is expected to facilitate all outreach and shall explain their approach and public participation plan in detail in their responses. The Consultant shall be required to provide analysis of data received from the public in a detailed final report.
- 4. In accordance with the Maryland Land Use Article. Section 3-201. Plan Preparation, the Consultant shall facilitate and shall prepare updates/refinements to the North East Comprehensive Plan-2012 (current Plan), Maps and illustrations to ensure consistency with the Maryland Land Use Article: Section 3-102. through Section 3-114; Section 1-201; and Section 1-509.
- 5. The Consultant may be required to provide additional services as the amendment/refinement process proceeds. Proposals should include a list of additional services the Consultant is experienced in dealing with when developing Comprehensive Plans.
- 6. The Consultant shall recommend changes to the North East Zoning Ordinance and Subdivision Regulations which may be applicable as a result of the Comprehensive Plan updates/amendments/refinements.
- 7. The Consultant shall provide a detailed timeline to accomplish the updated North East Comprehensive Plan-2012 (current Plan). Include the number of meetings to be conducted with Town staff, the Planning Commission, Agencies, public participation and Public

Hearing meetings. Include in the timeline the proposed percentage of completion throughout the project, the timeline of the final draft preparation and the timeframe for the Public Hearings and adoption, in accordance with the requirements of Maryland Land Use Article. Section 3-203. Plan Development.

In preparation for the public hearings for the adoption of the final draft of the updated North East Comprehensive Plan, the Consultant shall submit ten (20) paper copies, one Electronic version of Microsoft Word Version 13 and one Electronic PDF of the following to the Planning Office:

- 1. Updates/amendments/refinements, chapter by chapter;
- 2. Summary of compliance with the Maryland Land Use Articles referenced in **A. SUMMARY OF PROJECT**;
- 3. Summary of new or revised maps and illustrations on 8 ½" x 11" paper;
- 4. Summary of Public comments received;
- 5. Recommendations for amendments to the North East Zoning Ordinance and Subdivision Regulations;
- 6. Final Draft of the proposed Comprehensive Plan including illustrations and maps in the following sizes: 36"x48" and 11"x17".

<u>Final Products</u>: After adoption of the updated North East Comprehensive Plan by the Mayor and Commissioners, Consultant shall provide:

- 1. 20 color paper copies of the adopted North East Comprehensive Plan, illustrations and maps;
- 2. 1 PDF version of the adopted North East Comprehensive Plan, illustrations and maps;
- 3. 1 PDF of the adopted illustrations and maps which can be printable independently;
- 4. 36"x48" and 11"x17" color maps of each of the adopted Comprehensive Plan Maps, including but not limited to: Land Use Plan, Existing Land Use, Transportation Plan, Growth Plan;
- 5. 1 Electronic version of Microsoft Word Version 13 of the adopted North East Comprehensive Plan including illustrations and maps.

C. QUALIFICATIONS:
