Town Administrator

Mr. Cook-MacKenzie reported she attended the following meetings since the November 19, 2025 Town Board meeting:

- Cecil County Christmas Parade and Personnel Projects. The Town Administrator thanked the Mayor for witnessing all the efforts the town hall staff goes through to make this a great annual event
- Regarding Resolution 2025-12-01, modifying the policy regarding parade participant rules and regulations. With talking to Mayor Benson, this is a good opportunity to review the entire event and make positive changes where needed
- Met with the Assistant Town Administrator along with Grant Writer, things are going
 well especially the water projects, two grants will be submitted. Town Administrator
 advised the Board, the Grant Writer will be submitting a monthly report also

Water Superintendent, Ron Carter is continuing to see improvement in the test results
for the Rolling Mill Water Treatment Plant. The manganese is still an issue, he has
made a request to, Maryland Water Rural Association, they improve the quality of life
in the rural and small municipal communities of Maryland. By using their drone, they
will steer in the direction of creek to see if they can identify if the manganese is forming
during rainfall

Mrs. Cook-MacKenzie reported on behalf of the Director of Finance, there was a check mailed to a contractor that works for the town, Allied Control Services, Inc, who does the SCADA work for the Water Department. From the time the check was mailed and delivered to the bank it was intercepted and endorsed to another party, the check was in the amount of \$35,000.00. Mrs. Cook-MacKenzie stated the bank did notice and contacted the town right-away, a new check was issued to the contractor. The Director of Finance is working with the bank to have something in place so this does not happen again.

Assistant Town Administrator

Mr. Grant Handley reported he attended the following meetings since the November 19, 2025 Town Board meeting:

- Met with the Cecil County Public Library to discuss adding a Story Book Trail at the North East Community Park
- Completed the Old Town Lock-Up renovation, the building was open to the public during the Cecil County Christmas Parade and was very popular with many visitors
- Held the MS4 quarterly coordination meeting with Cecil County Stormwater; we are still awaiting a new permit
- Began advertising and the bid process for the Rolling Mill Finished Water Pumping Station Project, funded through an MDE grant

- The Town of North East will be hosting the Maryland Municipal League (MML)

A motion to approve Budget Amendment 2026-006 was made by Vice-Mayor Davis, seconded by Commissioner DeMatt and approved by all.

Mayor Benson asked for the Assistant Town Administrator to bring the Board up to speed regarding the Old Town Lock-Up and the cost. There was a budget amount of \$100,000.00 for the restoration of the building for most of the interior and exterior. There were 2 items that were not anticipated in the number. Additional costs:

- Run electric and have Delmarva install \$9,600.00
- Custom hardware from Michael Coldren Company. Historic Hardware \$8,000.00
- Fake brick paneling to blend the history (exterior material in case of flooding) \$8,000.00

The Assistant Town Administrator stated he will have a Budget Amendment prepared for the Board at the next Town Board meeting for approval. Mayor Benson stated he has been in conversation with town staff regarding his position in moving forward with the project.
